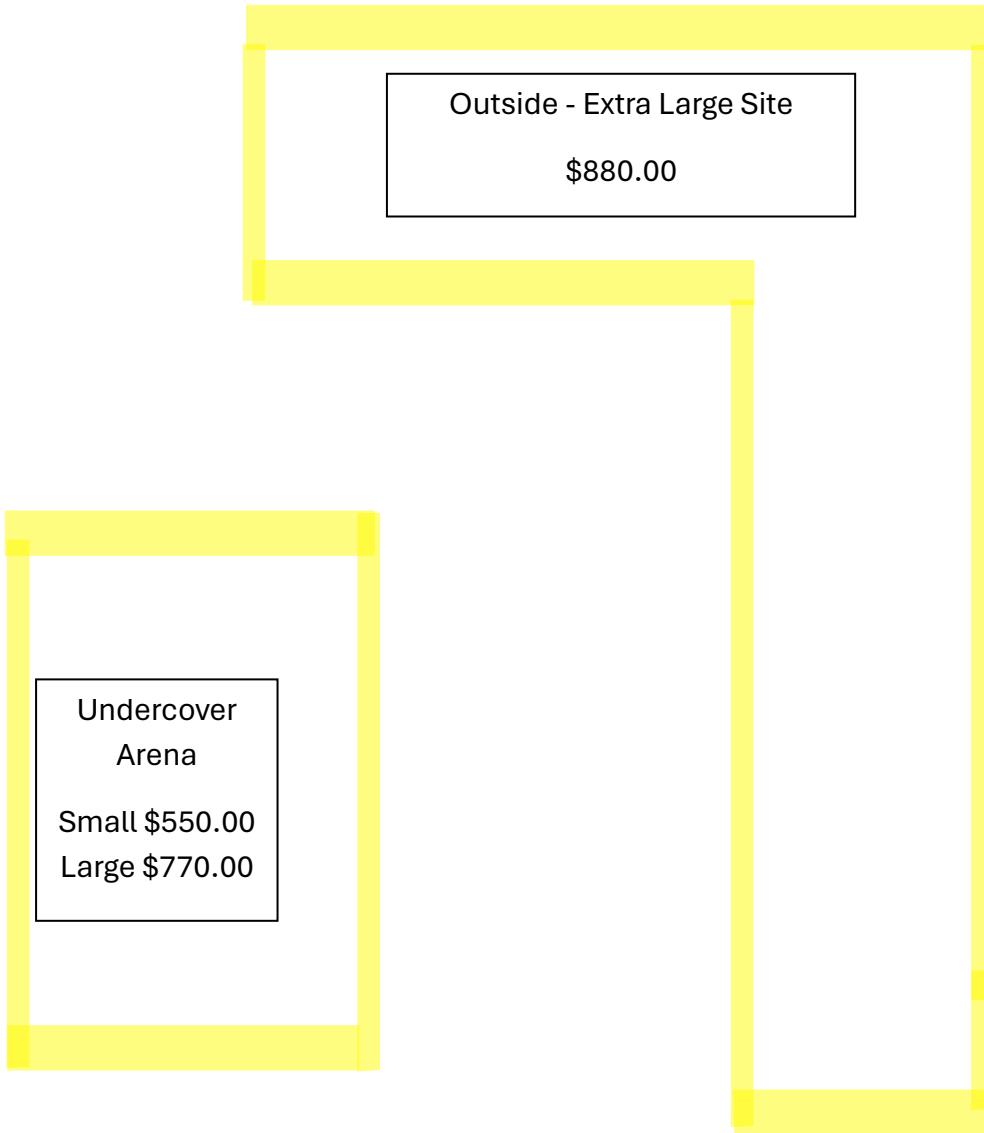

TERMS AND CONDITIONS

1. Preference for site allocations will be given to Event Sponsors and returning exhibitors that have fully complied with the Trade Space Terms and Conditions. Final placement will be at the discretion of the Trade Site Coordinator.
2. Trade sites are to be in the space allocated by the DDASHS, unless stated otherwise by the DDASHS Trade Site Coordinator. All vendors must follow any instructions provided by the DDASHS Trade Site Coordinator or DDASHS committee member.
3. Any disrespect shown to members of the committee will result in cancellation of the trade site and no refund of fees or charges.
4. A complete and correct application must be submitted with a Current Certificate of Currency, Public Liability Insurance (minimum \$20m) and policy number and, if applicable, a current food vendors licence and gas compliance certificate for the business.
5. Once payment is received your trade site is secured. There will be no refunds if trade site is cancelled after 31st October 2024.
6. All trade site vendors are responsible for the security of their sites.
7. Admission to the grounds opens Tuesday 26th November - there will be no admission prior to this date.
8. All vehicles and camping are to be kept within site boundaries.
9. All vendors power leads must be tested and covered in the case of wet weather and to give protection from vehicles driving over them.
10. All vendors dogs must be kept tied up or on a leash at all times and any dog faeces must be disposed of immediately.
11. ALL TRADE SITES MUST be left clean and tidy, otherwise any future applications to the event may be declined
12. In the event that your power arrangement causes fault to the grounds electrical supply, requiring an electrician, the person/s responsible for the fault may be accountable for charges incurred should it be deemed that your power arrangements were negligent.
13. Please ensure you adhere to COVID safe procedures at all times.
14. We will try to keep competition fair between trade sites, however there may be trade sites that sell similar products, and we will not entertain complaints or arguments around this.
15. At any time, the Darling Downs ASHS Branch reserves the right to change these Terms and Conditions. If there are any changes all site vendors will be notified accordingly.
16. Each trade site includes one camping site at no fee. More camping space may require a fee.
17. Up until the week of the sale all correspondence will be via email

Any vendors failing to comply with these Terms and Conditions may result in your trade space being cancelled with no refund of any fees or charges.
